# Canadian Conservation Achievement Awards Program

Each year thousands of Canadians demonstrate their commitment to wildlife conservation through active involvement. They may be volunteers, professionals, or people simply concerned about the quality of life in Canada. Their actions contribute toward the protection of our country's natural heritage for the benefit and enjoyment of future generations.

The Canadian Wildlife Federation established the Canadian Conservation Achievement Awards Program in 1978 to honour outstanding individuals and organizations whose achievements in the field of wildlife conservation deserve recognition.

CWF is one of Canada's largest conservation organizations with more than 300,000 members and supporters.

We invite you to participate in our program by nominating a deserving candidate for a prestigious Canadian Conservation Achievement Award.

All nominations for Canadian Conservation Achievement Awards are carefully evaluated by an Awards Committee. The awards are presented each year at the CWF Annual Meeting.

## Roland Michener Conservation Award

The Roland Michener Conservation Award was established in 1978 by the Canadian Wildlife Federation as a tribute to the former governor general of Canada, the Right Honourable Roland Michener, an outstanding outdoors person and past honorary president of the federation.

### Eligibility

Any individual who has demonstrated a commitment to conservation through effective and responsible activities that promote, enhance and further the conservation of Canada's natural resources is eligible for this award.

## Roderick Haig-Brown Award

In recognition of its role in developing a strong national voice for the recreational use of Canada's fisheries resources, the Canadian Wildlife Federation established the Roderick Haig-Brown Award in 1985. This award honours one of Canada's greatest outdoors person and writers on outdoor topics.

### Eligibility

Any individual who has made a significant contribution to furthering the sport of angling and/or the conservation, development and wise use of Canada's recreational fisheries is eligible for this award. Past Presidents' Canadian Legislator

### Award

The Past Presidents' Canadian Legislator Award was established in 1988 by the past presidents of the Canadian Wildlife Federation. This award is presented annually to an elected legislator in recognition of a significant contribution toward the conservation of wildlife in Canada.

### Eligibility

Any individual who is a provincial, territorial, or federal elected legislator and who has made a significant contribution to the conservation of wildlife in Canada is eligible for this award.

### **Doug Clarke Memorial Award**

The federation introduced the Doug Clarke Memorial Award in 1982 in memory of Dr. C.H.D. "Doug" Clarke. Dr. Clarke devoted his career to the philosophy, science and art of wildlife management throughout the world. At the time of his death in 1981, he was a director of the Canadian Wildlife Federation.

This award is presented to a Canadian Wildlife Federation affiliate for the most outstanding conservation project completed during the previous year by the affiliate, its clubs, or its members.

#### **Eligibility**

Any conservation project that was completed during the previous year by any Canadian Wildlife Federation affiliate, its clubs, or its members is eligible for this award. To be eligible, a project must be submitted by an affiliate. Details of a project must include a concise description of its purpose, activities, extent of participation by individuals, project costs and duration of the project, results achieved and a summary of how the project benefited wildlife.

### **Stan Hodgkiss Canadian Outdoorsperson of the Year Award**

Each year since 1975, the Canadian Outdoors person of the year Award has been presented to an outstanding individual in the field of conservation. The award has since been renamed in honour of the CWF founding president Stan Hodgkiss.

#### **Eligibility**

Any Canadian outdoors person who has demonstrated an active commitment to conservation in Canada is eligible for this award. All nominations must include a complete summary of candidate's outdoor and conservation activities including affiliations with organizations and service clubs, participation in civic affairs and youth groups, etc., as well as biographical information.

### **Youth Conservation Award**

The Youth Conservation Award recognizes youth groups and/or youth groups and their leaders who have undertaken wildlife, habitat, and conservation projects or activities.

#### **Eligibility**

Any Canadian youth group and/or youth group and their leader who have participated in a wildlife conservation project or activity in the previous year. Nominations must include a summary of the project or activity including information about the group, its members, and leader.

# Canadian Conservation Achievement Awards Program

Please submit a typewritten summary (not more than 10 pages) of your nominee's accomplishments and contributions to conservation. Include such information as organizational affiliations, memberships, service on boards and councils, past achievements, awards, distinctions and/or academic achievements, publications and papers, press clippings, photographs, etc., to support your nomination.

Keep in mind that your summary is what the Awards Committee will use to access your nominee. Please provide as much information as possible in order to assist the committee in making their decision.

Use a separate form for each nomination and for each award.

If you are nominating a project, summarize its purpose, the activities associated with the project, the extent of participation by individuals, results achieved and how the project benefited wildlife. You may include press clippings, photographs, slides, videos, magazine articles, etc., to support your nomination.

Nominations will NOT be considered unless adequate information is received.

Nominations received AFTER the stated deadline will not be considered until the following year.
